This application form is ONLY for NWT Indigenous individuals who wish to be considered in the application process for selecting members of the Aurora College Indigenous Knowledge Holders Council.

Aurora College's new tri-cameral governance model, comprised of the Board of Governors, Academic Council, and Indigenous Knowledge Holders Council, is the first of its kind within Canadian post-secondary institutions. Together, these three bodies will make decisions and recommendations on strategic directions, the business of the College, and on academics and research. The new governance system will help Aurora College become increasingly effective, efficient, sustainable, and better positioned to identify and respond to the needs of Northern residents.

The Indigenous Knowledge Holders Council will be integral to the tri-cameral governance structure, playing a pivotal role in shaping the institution's strategic direction and decision-making processes. The Council's main purpose will be to promote policies and operational decisions that foster the success of Indigenous students and staff at Aurora College, and the overall success of Aurora College.

Eligibility

To be eligible to apply for the Indigenous Knowledge Holders Council (IKHC), applicants must be:

- Indigenous individuals born in the Northwest Territories (NWT), or Indigenous individuals who have lived at least half their life in NWT;
- Priority will be given to Indigenous applicants who reside in the NWT.

- ✓ Applications will also be available at Aurora College's 19 Community Learning Centres (CLC), and applicants can request assistance and support in their home community from the CLC Community Adult Educator in completing the application form.

Please note: The 13 selected applicants will be required to provide Document Evidence related to place of birth, residency and social insurance number before recommendations to the Aurora College Board of Governors are approved in March 2024.

Required documents:

- Copy of birth certificate, or a copy of valid Canadian passport, or a copy of status card issued by Indigenous Services Canada;

 AND
 - Proof of residency Copy of one (1) valid document that shows your name and current home address to confirm that the NWT is your place of residence, e.g. signed mortgage, rental or lease agreement, rent receipt, utility bill (water, gas, oil, or power), or property tax form;

OF

Proof of living more than half your life in the NWT: letter or email from Health Services
 Administration indicating the initial date of NWT health card use.
