PURPOSE

This policy provides the context and guidance for the suspension, reinstatement, or termination of Aurora College post-secondary programs.

SCOPE AND LIMITS

This policy and its related procedures apply to:

- 1. All post-secondary programs that are being considered for suspension or termination; and
- 2. Suspended post-secondary programs that are being considered for reinstatement.

POLICY STATEMENT

Aurora College will evaluate the suspension, reinstatement, or termination of post-secondary programs against its strategic plan and academic plan.

Guiding Principles

- 1. Aurora College is responsible for delivering quality programs that are relevant and current.
- 2. Aurora College will be transparent and accountable in how it suspends and terminates programs

General

- 1.1 A program may be recommended for suspension or termination if one or more of the following conditions are met (but not limited to):
 - a. A minimum enrolment threshold has not been maintained;
 - b. Program admission has been suspended for at least two years;

- c. The program is no longer financially viable;
- d. The quality of the program has been compromised or the program no longer meets the required learning outcomes;
- e. The program represents an increased liability risk to the college;
- f. The program no longer aligns with the strategic or academic goals of the college;
- g. The program no longer meets the needs of relevant industry; or
- h. The program does not align with current and forecast labour market demand.
- 1.2 Proposals for the suspension, reinstatement, or termination of a program will be initiated by the relevant Vice President in consultation with their faculty.
- 1.3 The suspension, reinstatement, or termination of a program requires the approval of the Board of Governors.
- 1.4 Proposals for the suspension, reinstatement, or termination of a program will be comprehensively documented to assess potential consequences and effects on students.
- 1.5 When a program is suspended, the proposal should outline the conditions that need to be met for future reinstatement.
- 1.6 The suspension, reinstatement, or termination of a program will be communicated to all interested stakeholders.
- 1.7 Students enrolled in a suspended or terminated program will be provided with every opportunity to complete the program per the timelines outlined in policy *C.49 Program Completion Grace Period*.
- 1.8 Full details of the process for the suspension, reinstatement, or termination of a program will be developed through a transparent consultation process as documented in the *Program Suspension, Reinstatement, and Termination Procedure.*

DEFINITIONS

Program: A program is an integrated set of courses and related learning activities within an academic unit that collectively will lead to either a document of recognition, or achieving the entrance requirements of another program.

Program Reinstatement: The reactivation of a suspended program, allowing new admissions.

Program Suspension: A temporary cessation of a program whereby students will not be admitted to a program for a defined period of time.

Program Termination: Permanent closure of a program, which includes removal from future academic calendars and cessation of admission to the designated program.
