PURPOSE

Aurora College provides a transparent process for students applying to housing and a framework for prioritization of allocation of student units.

SCOPE AND LIMITS

This policy applies to Aurora College students living in or applying to live in Aurora College student housing.

Aurora College has a limited number of student housing units. The College attempts to house as many students as possible, but not every student who applies is guaranteed student housing.

Circumstances may require flexibility in the application of the policy and prioritization framework, on occasion.

POLICY STATEMENT

Student housing enriches the student experience by providing students with a safe and secure learning environment while on campus. Living in residence may support students to succeed in their academic pursuits. Aurora College utilizes a prioritization framework to select students for housing from the student applications received by the deadline.

Guiding Principles

1. Aurora College provides students with a safe and secure living environment while they are on campus attending classes.
2. Aurora College is committed to providing accessible housing, where possible, to students who have documented physical and/or medical conditions.

3. The selection process for student housing should be transparent based on the criteria in the priority framework.

DEFINITIONS

Accessible Housing: Student housing units that are adapted to the individuals who are intended to occupy it, including those who are disadvantaged by physical or medical conditions.

Student: A person who confirmed their program acceptance, registered, or has accepted to continue a program at Aurora College.

Note: for the purposes of this policy, *students* will include applicants
